## Highlights in 2006–2007

UBC's School of Community and Regional Planning (SCARP) is one of Canada's largest and oldest graduate planning programs, with a 55-year heritage in education, capacity building, research, and service. The school is focused on participatory planning for environmental, social, and economic sustainability. SCARP has the equivalent of 15 faculty and a masters and doctoral teaching program with over 150 students registered in degree programs each year. SCARP is also home to the Centre for Human Settlements, which leads major collaborative capacity building and research programs focused on community-based planning for poverty reduction in Brazil, Vietnam, and other Asian countries. It also has a suite of "sustainability collaboratories", research laboratories focusing on information and communication technologies, transportation, urban design, and disaster preparedness planning.

### Highlights

*The School made prominent contributions to the World Urban Forum (WUF), World Planning Congress, and associated events held in Vancouver in June 2006. SCARP students organised the highly successful international student conference, Planners for Tomorrow (P4T), which began as a web based, year-long dialogue among students from planning schools around the world, and culminated in a three-day Forum in Vancouver which created recommendations on the knowledge, skills and attitudes critical for the sustainability planner of tomorrow. *Faculty and students organized sessions and presented papers and videos for the World Planners Congress and World Urban Forum as well as several other associated conferences including the national meetings for architects and landscape architects.*

*Professor John Friedmann was honoured by being chosen as the first UN Habitat Lecture award winner, and delivered his Lecture at WUF. Professor Leonie Sandercock delivered the annual UBC/Laurier Lecture on Multiculturalism, which was broadcast on CBC Radio.*

*Professor William Rees was elected to the Royal Society of Canada.*

*Leonie Sandercock was awarded first prize in the BMW Group Award for Intercultural Learning, for her theoretical work on cosmopolitan urbanism and her practical collaboration with the Collingwood Neighbourhood House in Vancouver. Her documentary (jointly with Dr. Giovanni Attili) about the integration of immigrants in Vancouver through the Neighbourhood House, received Special mention at the International Federation of Housing and Planning film competition in Geneva in Sept 2006.*

*Larry Beasley, OC, who retired as CO-Director of Planning in the City of Vancouver, joined SCARP for a five year appointment as Distinguished Practice Professor.*

***Dr. Margo Fryer, Director of UBC's Learning Exchange, located in Vancouver's Downtown Eastside, was appointed as a faculty member of SCARP. Dr. Fryer leads UBC's Community Service Learning Initiative, which is funded by a grant from the McConnell Foundation. Dr. Fryer received the Community Service Award from the Province of British Columbia (Katie please check the description of this award on margo's CV).***

***Dr. Michael Larice, the School's leader of our Urban Design area of concentration, was appointed to a position at the University of Pennsylvania. He has been replaced by Dr. Maged Senbel, who has been teaching for the past three years in the College of Architecture and Planning at the University of Utah. Dr. Senbel has Masters degrees in both Architecture and Planning, and is a PhD graduate from our own PhD program.***

***Tony Dorcey stepped down as Director of SCARP after a highly successful seven year term, and was replaced by Leonie Sandercock on 1<sup>st</sup> July 2006.***

***Over the past year, 100 Master's and 16 Doctoral students were enrolled in UBC's program in Community and Regional Planning (SCARP). During this period 42 master's and 2 doctoral students graduated from the program.***

#### **Vision**

***At the School's Retreat in May 2007, SCARP's Mission Statement and goals were reaffirmed. In addition, we decided to rejuvenate the Centre for Human Settlements with a new mission, focussing on research and engagement addressing an urban world in sustainability crisis. Professor Bill Rees will chair a newly elected management committee to develop research ideas through CHS.***

## **Graduate Award Winners 2006–2007**

### ***Samara Brock***

***Canadian Institute of Planners (CIP) Award for Academic Excellence including a book prize and certificate bearing the CIP seal. The CIP award is granted to the student member who achieves the highest academic standing over the length of the program.***

### ***Mark Reismeyer***

***Real Estate Foundation award in Community & Regional Planning. A \$1,000 award is offered by the Real Estate Foundation to graduate student in SCARP who exhibits excellence in academic, professional and community activities in community planning and/or real property development.***

### ***Samara Brock***

***H. Peter Oberlander \$1,200 Prize and Medal. The award honours H. Peter Oberlander, the founding Director of the School of Community & Regional Planning and subsequently the founding Director of the Centre for Human Settlements.***

### ***Daniel Freeman***

***American Institute of Planners prize including a \$1,200 prize from SCARP. The American Institute of Certified Planners Prize is awarded to the most outstanding graduating student in Community & Regional Planning.***

### ***Colleen Brown***

***The Emergency Preparedness Conference award for \$3650 is offered to graduate students concentrating in Emergency Planning. Recipients will be invited to the annual Emergency Preparedness Conference and may be encouraged to present their work at a subsequent meeting. The award is made on the nomination of a Selection Committee, in consultation with the Faculty of Graduate Studies.***

### ***Leslie Shieh & Lisi Feng***

***Brahm Wiesman, Director of UBC's School of Community and Regional Planning from 1978 to 1987, initiated the first major overseas development projects of SCARP and the Centre for Human Settlements. As a result of his work, CHS was designated a Centre of Excellence by the Canadian International Development Agency in 1990. Madge Wiesman, with support from Brahm's friends, colleagues and former students, has endowed a scholarship in his memory. The Brahm Wiesman Memorial Scholarship will be awarded annually to a SCARP student in the Master's or Doctoral program.***

### School of Community and Regional Planning Scholarships

*Four scholarships totaling \$1,000 each are awarded to students entering the second year of their Master's degree at SCARP and are awarded for academic excellence. The Scholarships were established in 1990 from interest received on major grants the School received in the 1960's from the Richard King Mellon Charitable Trust Grant and the Donnor Canadian Foundation grant. In 2006-2007, the scholarships were given to Peter Giles, Adam Hunt, Jason Smart and Taylor Zeeg.*

## MASTERS PROGRAM 2006-2007

*SCARP's Master's Program constitutes the core of its academic and professional teaching program. As one of the best-known and comprehensive Planning programs in North America we received 153 applications for 2006-2007 as compared to 153 formal applications for 2005-2006, 187 in 2004-2005 and 218 in 2003-2004. We continued to improve our successful program completion rate, graduating 42 students in the 2006-2007 academic year.*

## **Centre for Human Settlements**

*The Centre for Human Settlements (CHS) takes as its mission “to advance knowledge of the dynamics of, and effective methods for, democratically planning the sustainable development of settlements.” The interdisciplinary research and capacity-building programs at CHS address a multiplicity of complex community development issues. In collaboration with academic, governmental and NGO partners, CHS advances knowledge through participatory action research, field tests of proposed planning methods, institutional capacity building, and mutual learning.*

*CHS has an established record of research in planning for sustainable development that explores local and global paths towards achieving it. In 1991, CHS was designated an International Centre of Excellence in International Development by the Canadian International Development Agency (CIDA). Since then, the Centre has been awarded four other major CIDA grants; funding from the United Nations Development Program (UNDP) for a training program on planning for sustainability in Hanoi, Vietnam; and funding from the Social Sciences and Humanities Research Council (SSHRC) to initiate an international gender and development network.*

*Under the CHS umbrella, the Disaster Preparedness Resource Centre (DPRC) has been successful in obtaining funding for a variety of research and training projects and conferences. Faculty Associates have also been active in individual research projects funded by a broad spectrum of national and international funding agencies. Current projects are summarized below.*

### **Canada-Indonesia Symposium - The New Shape of Government in Indonesia and Implications for Bilateral Relations**

Project Leader: Michael Leaf

Project supported by a grant for \$26,500 from the Asia Pacific Initiatives Conference Fund, Foreign Affairs Canada

On October 12, 2004, the Centre for Southeast Asia Research hosted a one-day symposium on the future of Canada-Indonesia bilateral relations in collaboration with Simon Fraser University International and the Indonesian Consulate in Vancouver, and with financial support from Foreign Affairs Canada. The intent of the symposium was to promote dialogue on the changing nature of Indonesian society and economic development in light of ongoing changes in the Indonesian government, in particular the recently completed cycle of elections resulting in the presidency of Susilo Bambang Yudhoyono, and to generate new ideas regarding the nature of Canadian engagement in Indonesia. The symposium was held at the SFU Harbour Centre campus and was attended by over 70 participants in addition to the presenters.

Chaired by CSEAR Director Michael Leaf, the symposium was led off by two keynote addresses by Randolph Mank, Canadian Ambassador to Indonesia, who reviewed current trends in Indonesian democratization and development, emphasizing Canada's role and

interests in particular, and Eki Syachrudin, Indonesian Ambassador to Canada, who discussed current political developments relative to the broad sweep of political and social change in Indonesia since the time of independence in 1949. This introductory session was followed by three panels, covering: domestic, regional and international security, including questions of political reform, national unity and the war on terrorism; the outlook for the economy and current factors shaping the investment climate; and social development, human rights and the environment, with specific attention to Canadian aid priorities. Speakers on these panels included: Dr. Rizal Mallarangeng (Director of the Freedom Institute), Prof. Dr. Azyumardi Azra (Rector, Universitas Islam Negeri), and Dr. Jacques Bertrand (University of Toronto) on the security panel, which was moderated by Dr. Abidin Kusno (UBC); Dr. Umar Juoro (Center for Information and Development Studies), and Greg Elms (Canada-Indonesia Business Development Office) on the investment panel, moderated by Chris Dagg (SFU); and Dr. Amanda Katili-Niode (Syarifa Foundation), Rustam Ibrahim (YAPPIKA), and Dr. Roy Culpeper (North-South Institute) on the social development panel, moderated by Michael Leaf. The final panel, chaired by Dr. Irman Lanti of the Habibie Center, brought back all of the speakers in a discussion of what recommendations could be put forth regarding specific Canadian initiatives across all three of these broad themes. Ideas from the presentations and the ensuing discussions will be compiled in a brief summary document focusing on the symposium's recommendations, which was followed by the publication of the symposium proceedings.

### **The Asian Urban Laboratory**

Project Leaders: Michael Leaf and Abidin Kusno (Institute of Asian Research)  
Project supported by grants totaling \$135,000 from the Canada Foundation for Innovation and the BC Knowledge Development Fund, 2005.

The Asian Urban Laboratory (AUL) is now under development at the IAR with support from the Canada Foundation for Innovation and the BC Knowledge Development Fund. This new facility, under the direction of Abidin Kusno of the Centre for Southeast Asia Research, will be dedicated to promoting collaborative research among local, national, and international scholars working on both historical and contemporary aspects of urbanism and urban change in Asia. Establishing the AUL within the IAR will thus provide critical support for the work of Dr. Kusno and various other members of the University in two regards; first, through the digitization and utilization of existing graphic materials on Asian urbanism, establishing a Digital Image Library of materials on Asian cities and urban change, and second, through the development of an Asian Urban Database which will draw together statistical, cartographic, and textual materials focused on selected Asian cities. Taken together, these two components will provide a core resource for promoting collaborative, interdisciplinary research on urban change throughout the region, thus helping to complement and strengthen UBC's position as Canada's world-leading academic institution for the study of Asian urbanization. Building upon the interdisciplinarity of the IAR itself, the facility would thus establish a

unique national research capability that would attract scholars from various disciplines across the Social Sciences and the Humanities to the study of cities in Asia.

### **Challenges of the Agrarian Transition in Southeast Asia**

Project Leader: Rodolphe DeKoninck, University of Montreal

Co-investigators: Michael Leaf, et al.

Project supported by: Social Sciences and Humanities Research Council, Major Collaborative Research Initiatives, for \$2.5 million, from 2005 – 2010.

The Social Sciences and Humanities Research Council of Canada has awarded a Major Collaborative Research Initiative (MCRI) grant for the study of “The Challenges of the Agrarian Transition in Southeast Asia” (or ChATSEA). This five-year, \$2.5 million program will critically examine the ongoing societal transformations in Southeast Asia from primarily non-urban populations dependent upon agricultural production and organized through rural social structures, to predominantly urbanized, industrialized and market-based societies. The consortium of researchers involved in this program is led by Rodolphe De Koninck of the University of Montreal, and includes Michael Leaf, Director of the UBC Centre for Southeast Asia Research, along with others from Canada, Europe, and Australia and collaborators from Indonesia, Malaysia, the Philippines, Thailand, and Vietnam. The work of this program is organized around six themes: 1) agricultural intensification and territorial expansion; 2) increasing integration of production into market-based systems of exchange; 3) accelerating processes of urbanization and industrialization; 4) heightened population mobility both within and across national borders; 5) intensification of regulation, as new forms of private, state and supra-state power are developed and formalized to govern agricultural production and exchange relationships; 6) processes of environmental change that modify the relationship between society and nature to reflect new human impacts and new valuations of resources. Dr. Leaf will act as the process coordinator for the urbanization and industrialization theme, thereby creating links between the ChATSEA program and other UBC initiatives regarding Asian urbanization.

### **Informality and Governance in Peri-urban Southeast Asia: A Study of the Jakarta and Hanoi Metropolitan Regions**

Project Leader: Michael Leaf

Project supported by: Social Sciences and Humanities Research Council, Standard Research Grant, for \$92,646, from 2006 – 2008.

Indonesia and Vietnam, like other developing countries in Southeast Asia, are struggling to cope with the effects of extremely rapid urbanization. This is a phenomenon associated with each country’s urban transition - that is, the historic shift from a society defined by a rural majority population to one in which urban populations predominate. Particularly problematic are the peri-urban areas adjacent to the major cities, as these are zones of hyper-rapid change, characterized by the influx of rural migrant populations, the outward movement of suburbanizing urban dwellers, and unprecedented local

administrative challenges. Erstwhile rural villages must quickly adapt to being part of the city, with all the demands for urban infrastructure, services, land use, and environmental controls that this implies.

The basic processes by which peri-urbanization occurs are shaped by a mix of both formal (state-regulated) and informal (non-regulated) means, that in practice often subvert the expressed goals of state-defined urban planning. The research is therefore based upon a framework of regulatory informality, focusing on the complex interactions between state and non-state actors in the shaping of peri-urban change. Regulatory issues which unfold from processes of peri-urbanization and which will be examined in this research include: (a) land use and building construction, (b) security of property rights, (c) delivery of infrastructure and services, and (d) environmental protection.

The proposed research is expected to contribute to knowledge in two ways. First, in regard to policy implications, the research will seek to understand the bases of localized regulatory practices outside of direct, or formal, state control, raising the possibility of articulating new means of regulation in the peri-urbanizing regions of two major Southeast Asian cities. Second, in more theoretical terms, the research will contribute to the recent resurgence of interest in the study of urban informality and informalization in market-driven development. Dissemination of results will be undertaken through the presentation and publication of scholarly papers in both Asia and North America, and through a book project bringing together the Hanoi and Jakarta case studies with others in the region.

### **Bilateral Symposium on Canada-Indonesia Relations: Cooperation in a Time of Change (Jakarta and Banda Aceh, Indonesia, 8-10 December 2005)**

Project Leader: Michael Leaf

Project supported by a grant for \$22,500 from Foreign Affairs Canada

The 2005 Bilateral Symposium on Canada-Indonesia Relations was designed to build upon the momentum of the 2004 Symposium by bringing together representatives from government, the private sector, non-governmental organizations, and academia to examine the current state of bilateral relations, particularly in light of major events over the past year. The single most momentous event in this respect was the Indian Ocean Earthquake and Tsunami of 26 December 2004 that destroyed much of the coastal areas of the Aceh Province and caused the deaths of over 170,000 people and the displacement of another 500,000. From the perspective of bilateral relations, one major effect of this destruction has been the tremendous efforts at cooperation between Indonesia and the international community for relief, recovery, and reconstruction in the affected areas. A second consequential outcome has been the cessation of fighting between Indonesian Armed Forces (TNI) and the separatist Free Aceh Movement (GAM), and the beginning of a still-fragile peace process.

---

For these reasons, it was decided to organize the 2005 Symposium in two parts, with a day of presentations and discussions in Jakarta (Dec 8), followed by a second series of presentations and discussions in Banda Aceh (Dec 10). The intention of organizing this as a two-part symposium was to be able to engage analysts and policy-makers in Jakarta as well as to gather the direct input of local officials, local and international reconstruction workers, and other observers in Banda Aceh.

The Jakarta component of the symposium was held at the Indonesian Department of Foreign Affairs (Jalan Taman Pejambon 6) and organized by the Habibie Center in collaboration with the Indonesian Department of Foreign Affairs and with the cooperation of the Canadian Embassy in Jakarta, the UBC Centre for Southeast Asia Research and Simon Fraser University International. The event was structured as a roundtable discussion, with a core group of approximately eighteen Indonesian and Canadian participants and an additional audience of nearly fifty, representing government agencies, non-governmental organizations, academic institutions, the private sector and the media. Presentations and discussions were organized around a series of three panels addressing respectively: the political and security environment; the business and investment climate; and development cooperation, with each panel lead by a pair of presentations by Indonesian and Canadian representatives (see symposium agenda in addendum for details). These panels were preceded by welcoming comments, including those of Canadian Ambassador Randolph Mank, who reviewed the progress toward addressing the previous year's recommendations, and a keynote address by Mr. N. T. Dammen, who spoke on behalf of Dr. Nur Hassan Wirajuda, Indonesian Minister of Foreign Affairs. Core roundtable participants and presenters included six women and nine members of the larger audience were women out of a core group of approximately eighteen Indonesian and Canadian participants and an additional audience of nearly fifty

The portion of the symposium held in Banda Aceh was organized by the Islamic State University (Institut Agama Islam Negeri – IAIN) in collaboration with the Canadian Embassy in Jakarta, and was held at the Ar-Raniry campus of IAIN in Banda Aceh. In addition to serving the basic goals of the project, the Banda Aceh component of the symposium had the added benefits of directly involving faculty and students from a local university in Banda Aceh, and providing a public forum for the assessment of post-tsunami reconstruction efforts and peace-building in Aceh. Response to the symposium was enthusiastic, with a total of over 140 attendees, including more than twenty non-Indonesian representatives of multilateral, bilateral or non-governmental organizations involved in reconstruction efforts. More than 30 of the total attendees were women, and three of the fifteen core presenters were women. Following introductory remarks and two keynote addresses, giving, respectively, an overview of the Indonesian government's efforts at rehabilitation and reconstruction and an overview of CIDA programming to address reconstruction, the main presentations of the day were structured into two panels. The first focused on challenges and lessons learned as efforts move into the longer-term reconstruction phase, while the second panel addressed political and developmental aspects related to reconstruction, specifically dealing with the challenges of peace-building in Aceh after so many years of conflict. Each panel consisted of four

presentations by Indonesians and Canadians, representing governmental, non-governmental and academic perspectives.

***The Promises And Limits Of International Criminal Justice: The “Extraordinary Chambers” In Cambodia: A Roundtable Discussion (2 – 4, February 2006)***

Project Leader: Michael Leaf

Project supported by grants for \$10,000 each from Foreign Affairs Canada and the Canadian Consortium on Human Security

Thirty years after the accession to power of a regime that saw the untimely deaths of some 1.7 million of a population of seven million in less than four years, Cambodians have not yet had an accounting of the culpability of its leaders. In 1997, the Royal Government of Cambodia called upon the United Nations to assist in setting up a tribunal, and agreement was finally reached in 2003 for the establishment of the “Extraordinary Chambers for the period of Democratic Kampuchea” (ECDK), involving Cambodian and international judges and prosecutors. The objectives of the ECDK, aside from the obvious need to mete out justice for the atrocities of the Democratic Kampuchea (Khmer Rouge) regime, can be said to be (a) to promote national reconciliation after 35 years of conflict; (b) to advance the acceptance in Cambodia of the rule of law; (c) to build competence among the Cambodian judiciary; and (d) to satisfy the Cambodian population that there is finally to be accountability for the “auto-genocide” perpetrated by the murderous regime.

The objective of this roundtable conference was to review the history of efforts to bring the Khmer Rouge leadership to justice for crimes against humanity between April 1975 and January 1979, and to analyze steps taken toward a hybrid “Cambodian model” of a national tribunal with the participation of international judges and prosecutors. The roundtable is also intended to plant the seeds for a conference or series of conferences to be held in Cambodia dealing with the ECDK in the context of other international post-conflict methods of resolution. Roundtable presentations and discussions examined the effects of the Cambodian process on human security in a fragile state, particularly in stabilizing the peace, preventing further conflict in the region, promoting good governance and accountability, and encouraging acceptance of judicial reform and international norms respecting the rule of law. The roundtable looked specifically at the legal framework of the process, the context and implications for the political situation in Cambodia and social development objectives, and examined in particular at the role of international assistance vis-à-vis “ownership” of the process.

The roundtable consisted of two parts: the first, a series of public sessions, beginning with a keynote address and discussions on the evening of Thursday, Feb 2, and continuing with a full day of panel presentations and roundtable discussions on Friday, Feb 3; and the second, a closed session on Saturday, Feb 4, for roundtable participants to develop ideas for further project development based upon the outcomes of the previous

days' discussions. The public portion of the event consisted of thirteen presentations by invited roundtable participants and extensive discussions between participants and audience members (see Addendum for Conference Program). In addition to the 19 members of the roundtable (including presenters, moderators and discussants), at least 39 audience members attended all or part of the public presentations.

## **CANADA**

***EMERGENCE Canada (Estimation and Mapping of Employment Relocation in a Global Economy in the New Communications Environment): A Study of Employment Relocation in the Global Economy***

***Principal Investigator: Penny Gurstein; Co-Investigators: Ursula Huws, Analytica Social and Economic Research, Ruth Buchanan, UBC Faculty of Law, and Laura Johnson, University of Waterloo School of Planning***

***On March 17, 2003, the SSHRC INE (Initiative on the New Economy) program provided funding of \$253,000 for this three-year research project which links with the European Union and Australian-funded EMERGENCE Projects (Website: [www.emergence.nu](http://www.emergence.nu)). The EMERGENCE Canada ([www.chs.ubc.ca/emergence/](http://www.chs.ubc.ca/emergence/)) project examines the outsourcing of telemediated employment between firms within Canada and between Canada and Asia, and possibly Latin America, and compares these practices to ones in Australia and the EU. Telemediated or 'e-work' refers to labour that involves processing information that can be transmitted by a telecommunications link.***

The trajectory of the work experience is traced through thirteen case studies of tele-mediated relationships at various points in the global supply chain, a process also described as "global sourcing." The business functions investigated were: data processing; systems and software development and maintenance; accounting and financial management; telesales; customer services; training and staff development; and editorial and design functions.

EMERGENCE Canada is a partner in an interdisciplinary, international project, EMERGENCE: <http://www.emergence.nu>. The international project identified several trends in outsourcing that has been substantiated by the Canadian case studies. In particular, it was found that the 'source/destination' distinction did not adequately portray the employment relocation. The Canadian case studies, because they were done several years after the EU studies, depicted a much more evolved use of intermediaries and a lengthening and interweaving of the global supply chain.

Our study results go beyond the arbitrary discourse around outsourcing and globalization, which assumes a lack of agency and choice by communities, and that cities must follow market dictates without question. We shed light on how the increased pace, variety, and extent of new spatially-diffuse production relationships challenge both global and national urban spatial hierarchies. We also examine fundamental aspects of how such arrangements may change workers' relationships to, and actions within, their communities. Findings suggest the need for a range of planning policy approaches which recognize: the increasingly networked aspects of economic production and control; and the need for new ways of anchoring worker relationships to community.

---

EMERGENCE Canada has disseminated its results in a variety of venues. Workshops for academics (three); policymakers and union representatives (two); and the private sector (two) were held. A Rockefeller Foundation Award allowed an international workshop of academic and researchers to be organized. Numerous academic publications (11 refereed; 1 non-refereed), presentations in conferences, a website: [www.chs.ubc.ca/emergence](http://www.chs.ubc.ca/emergence), media interviews, reports (1) and public addresses allowed further dissemination of the results. A video of the results of the research is in production.

***Government Responses to Poverty and Income Inequality and their Effects on Children and Families (a collaborative study within The CHILD Project: Building a Consortium for Health, Intervention, Learning and Development in a Community Setting)***

***([www.earlylearning.ubc.ca/CHILD/research\\_child\\_poverty.htm](http://www.earlylearning.ubc.ca/CHILD/research_child_poverty.htm)) has received funding of \$322,000 for a 5-year study within the larger, SSHRC MCRI-funded grant for the CHILD (Consortium for Health, Intervention, Learning and Development) Project. Ethical Approval for this study was received on June 13, 2003.***

***Despite a relatively strong economy, a significant minority of Canadians, about 1 in 10 working age households, are being left behind in deep and continuing poverty and mounting income inequality. Their ranks disproportionately include single parent families (primarily lone mothers), some recent immigrants, persons with disabilities and aboriginal Canadians. This project focuses on an understanding of the experience of children and families in these circumstances in British Columbia, and especially the experiences of families who are currently undergoing reductions in income security, child care, employment standards, access to justice and other supports to families. The project tracks 30 families from urban and rural locales over three years to understand the impact that social policies play in poor people's lives.***

***We argue for poverty studies that do not demonize the poor and place them in categories of "deserving" and "undeserving." Rather, research needs to seek to understand the underlying causes of poverty and demystify the experiences of the poor so that appropriate policy initiatives can be formulated. Research on poverty mainly looks at aggregate data. Relatively few studies investigate the experiences of poverty on a qualitative basis. This study intends to provide a multi-methods perspective on this issue by both researching the large quantitative indicators of poverty and the qualitative life stories. This research will help frame the policy context for interventions to improve the lives of children at risk.***

This study occurs in two sites: urban (Vancouver, the northeast section covered by Main-Renfrew; Broadway-Waterfront) and rural/remote (Bulkley Valley—the area centred around Smithers covering Hazelton to the west and Huston to the east). The selection of an urban and rural community is based on the assumption that the effects are likely to be different given the economic restructuring and the sense that there is a growing urban-rural divide. North-East Vancouver has a high concentration of lone mothers on Income Assistance and this should make it easier to recruit/select lone mothers for interviews, while the Bulkley Valley has been clearly impacted through loss of public sector jobs.

*I developed two new courses in SCARP: The Social Learning Studio I and the Social Learning Studio II. Both courses educate students about how social learning processes influence planning practice by giving students hands-on experience planning and then leading or doing short-term projects in the community. While the enrolment in the first offering of the Social Learning Studio I was low, the students indicated strong appreciation for the course as evidenced by unsolicited feedback given to the Director of SCARP. Enrolment for the May/June 2007 Social Learning Studio II course is at 9 students as of March 31.*

*I oversaw the successful launch of the UBC-Community Learning Initiative (UBC-CLI), a new model for curricular Community Service-Learning (CSL) at UBC. This year, 200 students in a variety of undergraduate courses completed 22 different CSL projects in 13 non-profit organizations in the Lower Mainland. These projects were completed over 3 or 4 days in February during Reading Week. The projects were integrated into courses in the following disciplines: Applied Science, Biology, Sociology, First Nations Studies, Italian Studies, Interdisciplinary Health and Human Services, the Coordinated Arts Program, and Food, Nutrition, and Health.*

*UBC's commitment to CSL continues to grow under my leadership, with support from the staff team at the Learning Exchange and the UBC-CLI as well as support from faculty members across the university and staff from units such as Student Development and Residence Life. Because of our increased emphasis on integrating students' experiences in the community with the curricula, the number of students doing CSL in non-profit organizations and public schools as part of a course has increased significantly, going from 200 last year to 350 this year.*

*I was the principal applicant on a TLEF grant that was completed this year. This collaborative project developed several resources to support faculty participation in CSL, including a CSL at UBC website ([www.csl.ubc.ca](http://www.csl.ubc.ca)), an introduction to managing risks in CSL, and an annotated bibliography of CSL literature.*

---

*I was invited to give three speeches to large groups of students this year. I gave two speeches to the 200 students who took part in Reading Week CSL projects in Vancouver schools to introduce them to the key themes for their reflections during the projects, including the meaning of global citizenship, and to sensitize them to some of the complex questions that arise when students develop “helping” relationships with inner city children. I also gave the closing speech at the Multidisciplinary Undergraduate Research Conference, during which I emphasized the need for research to connect with real-world issues and the people who live and work in the midst of these issues, and who therefore know the issues from the inside.*

*The UBC-CLI includes a research and evaluation component that is investigating operational aspects of the model's implementation as well as its outcomes. This year, I have worked with UBC's Planning and Institutional Research unit (PAIR) to design and implement a study exploring the question of whether students' experiences doing CSL will affect the extent of their perceived engagement with UBC as a learning environment as evidenced by scores on the National Survey of Student Engagement (NSSE). In addition, I am overseeing an*

*evaluation of the model's launch that includes interviews with the faculty members and non-profit organizations that were involved this year. I am in discussion with faculty and staff leaders of the CSL program at the University of Alberta about collaborating on research related to CSL as well as participating on a national working group which is developing strategies and protocols to evaluate CSL programs and their outcomes.*

*I have initiated a research collaboration involving the Vancouver School Board and faculty and graduate students from Education to develop a letter of intent for SSHRC's Community-University Research Alliance (CURA) program. We are in discussion with faculty from other UBC units including Medicine and the Human Early Learning Partnership (HELP) about their participation in the project. The proposed CURA project will establish and evaluate a model for the engagement of universities in public schools that will strengthen civil society through a variety of experiential, community-based learning programs and initiatives.*

## Appendix H: Honourary and Adjunct Appointments

- **Larry Beasley**, Distinguished Practice Professor  
Larry is Director of Central Area Planning and Co-Director of Planning for the City of Vancouver. He is Chair of the Development Permit Board, has sat on the Urban Design Panel, and is the City Project Manager for the Trade and Convention Centre Expansion Review Program. With 22 years of civic service, Mr. Beasley has been the City's Senior Area Planner and was director of the Vancouver Legacies Program in 1986, raising \$3.5 million from the private sector for civic projects. He has advised Ottawa's National Capital Commission, Toronto's Royal Commission on the Harbourfront, the City of Auckland, New Zealand, the cities of Xi'an and Tianjin in China, and various Canadian and U.S. cities. He helped found the Forum for Planning Action and the Little Mountain Neighbourhood House, and is on the Board of Vancouver International Film Festival. He teaches *Post-Occupancy Evaluation* (Plan 548I) and *Practical Practice: City Planning as a Craft* (PLAN 548P).
  - **Pat Carney**, Adjunct Professor  
Senator Carney had a career in journalism and economic consulting before entering politics. She is a former federal M.P. and Cabinet Minister (1980-1988) and President of the Treasury Board. She was appointed to the Senate of Canada in 1990. She received the UBC Alumni Award for Distinguished Service for 1989.
