Master's Program

SCARP's Master's Program constitutes the core of its academic and professional teaching program. As one of the best-known and comprehensive Planning programs in North America we received 160 formal applications as compared to 123 in 1998-99, 121 in 1997-1998, and 130 in 1996-1997. We continued to improve our successful program completion rate, graduating 29 students in the 1999-2000 academic year.

For 1999-2000 the applicants accepting our offer had undergraduate degrees in Archaeology, Architecture, Art History, Environmental Biology, Business Administration, Ecology, Economics, Environmental Studies/Geography, French/Russian, Geography, History, Home Economics, International Development, International Relations, International Relations/Elementary Education, Landscape Architecture, Psychology/History of Science & Medicine, Sociology and Urban & Regional Planning.

Fifty-nine applicants were admitted and 29 accepted the offer. The average age was 28 (3 were under 24 years old). 9 males and 20 females accepted our offer.

Community and Professional Programs (CaPP)

During the 1999-00 year the difficult decision to discontinue the Community and Professional Programs division of SCARP was finalized. Faced with decreasing operational revenue from the university, the School was forced to reduce spending in areas such as CaPP that were not core to the central programs.

CENTRE FOR HUMAN SETTLEMENTS

The Centre for Human Settlements (CHS) takes as its mission “to advance knowledge of the dynamics of, and effective methods for, democratically planning the sustainable development of settlements.” The interdisciplinary research and capacity-building programs at CHS address a multiplicity of complex community development issues. In collaboration with academic, governmental and NGO partners, CHS advances knowledge through participatory action research, field tests of proposed planning methods, institutional capacity building, and mutual learning.

CHS has an established record of research in planning for sustainable development that explores local and global paths towards achieving it. In 1991, CHS was designated an International Centre of Excellence in International Development by the Canadian International Development Agency (CIDA). Since then, the Centre has been awarded four other major CIDA grants; funding from the United Nations Development Program (UNDP) for a training program on planning for sustainability in Hanoi, Vietnam; and funding from the Social Sciences and Humanities Research Council (SSHRC) to initiate an international gender and development network.

Under the CHS umbrella, the Eco-Risk Research Unit (ERRU) and the Disaster Preparedness Resource Centre (DPRC) have been successful in obtaining funding for a variety of research and training projects. Faculty Associates have also been active in individual research projects funded by a broad spectrum of national and international funding agencies. Current projects are summarised below.

BRAZIL

Community Based Watershed Management in Santo André

Project Director, Peter Boothroyd; Project Coordinator, Erika de Castro

The Community Based Watershed Management (CBWM) project is a four-year CIDA-funded project that started in October 1998. Since then, the initial phase of collecting and organising data has been accomplished, as well as most of the training workshops realised. Santo André is one of thirty-nine municipalities in the Sao Paulo Metropolitan Area (SPMA), the second largest city in Latin America. Sixty percent of the municipality is located in reserve areas that were established to preserve watersheds, green areas and natural parks. The metropolitan urban expansion has been a continuous source of pressure to increase the number of people living in the WPA, and so increasingly threatening the water quality of the metropolitan watersheds. The project has been undertaken to proactively address issues arising from human settlement in environmentally sensitive areas. The need to integrate informal and irregular settlements effectively into the urban system is the primary issue. The purposes of this project are:

1. To introduce Community-Based Watershed Management (CBWM) methods to Watershed Protection Areas in Santo André, with applicability to other communities and municipalities
2. To improve the quality and availability of information necessary for municipal decision-making related to watershed management
3. To expand institutional linkages between Canada and Brazil

Highlights of the CBWM project during the past year are as follows:

- Biophysical, social and economic information has been collected and organized. The compiled biophysical data is now being entered into a GIS system.
- A qualitative survey, designed to address subjective perceptions of the past, present and future of the whole Parque Andreense, will be completed this year.
- A number of workshops have been conducted or are currently being planned. Training and workshop topics include: conflict management, capacity building, social impact analysis and gender awareness.
- The development of the pilot project involved a participatory planning process, which was followed by a series of meetings and group work sessions to design the project with the community. Work has begun on the implementation of the suggestions to address negative environmental impacts and improve services and infrastructure.
- In February 2000, a “task-group” consisting of community and municipal representatives was established. They are responsible for monitoring, evaluating and guiding implementation of project actions.

- Training has been provided for Brazilian participants in the areas of conflict resolution, participation in planning processes, multi-stakeholder management, municipal management, social impact assessment, environmental sensitivity analysis, NGOs and community-based groups, organizations and actions, regional and inter-municipal approaches and arrangements of watershed management, hypermedia and GIS use in planning.
- Information sharing is occurring at all levels and cross-culturally

The CBWM project is expected to:

- Contribute to capacity development and institutional strengthening of the Santo André Municipality and its partner organisations by helping to develop, implement and evaluate concepts and policies related to social and environmental issues.
- Strengthen the community as an effective partner of the municipality in order to facilitate meaningful participation in the planning and management of the watershed protection area.
- Identify means to minimize damage to the environment by settlements in sensitive watershed areas, especially in informal settlements; and
- Cultivate stewardship consciousness for the watershed area residents.

BRITISH COLUMBIA

Interdisciplinary Perspectives on Child and Family Health and Well-being

Principal Investigator, Penny Gurstein; Co-investigator Dr. Chris Lovato, Associate Professor, UBC Dept. of Health Care and Epidemiology and Research Associate of the BC Research Institute for Child and Family Health; Research Assistant: Sally Ross, MA student, SCARP

Children and youth rarely have the opportunity to participate fully in decisions that affect their lives. The theoretical literature on participatory models only infrequently mentions children and youth. In contrast, children and youth advocates reiterate that cities need to be planned and managed as if children and youth mattered and that health programs need to be delivered with children and youth in mind.

In February 2000, the SSHRC/UBC General Research Fund granted \$2,500 for this exploratory study which will: define what participation means in the above-mentioned context, address why children (aged 5-12) and youth (aged 13-18) should be involved, identify barriers to children's and youth's participation, provide examples of effective participation models for children and youth, and develop a set of research questions that could be investigated in further studies. The research design includes a literature review to identify models of participation and existing programs and strategies; an inventory of children and youth programs in the Lower Mainland in order to identify those which can be studied in greater depth through focus groups and interviews; and analysis of the data for the research paper. To date, twenty organizations have been surveyed and four programs were identified for in-depth focus groups and interviews to be conducted between June and December 2000.

Seeking Solutions: Building Regional Alliances To Combat Homelessness, Crime And Drug Addiction
Co-Directors: Penny Gurstein and Brian Elliott, UBC Dept. of Anthropology and Sociology

The SSHRC Community-University Research Alliances program provided funding of \$5,000 to develop this project proposal to link the research expertise of universities and colleges with the practical

experience of grassroots organizations routinely struggling with some of the most intransigent individual and collective problems in our society. Of general concern is the growth of striking social inequality and injustice in the apparently prosperous and rapidly urbanizing Vancouver region in BC. The proposal was submitted to SSHRC in October 1999 but, unfortunately, did not receive funding.

Social Construction of Marginalization: Case Study of the Portland Hotel Society
Principal Investigator: Penny Gurstein

The UBC Humanities and Social Sciences Research Fund granted \$3,500 for this study, which examines the social construction of policies affecting the most marginalized populations in our society (i.e., people with multiple diagnoses such as mental illness, HIV related illness and IV drug addictions) and the part played in their creation by dominant cultural scripts (i.e., myths, stereotypes and stigma). Framed in the context of qualitative policy research, the project is investigating the effects of wider societal policies, as well as the narratives guiding community service professionals, on the lives of the residents of the Portland Hotel, a non-profit housing society for the hard to house. It addresses the questions: who are the hard to house, and how can their needs be met? The research aims to (1) provide a more theoretical understanding of the social construction of social policies; and (2) better inform policy makers about those for whom they are making policies.

New Service Clusters in the Metropolitan Core: Intersections of Tertiarization, Urban Culture and Milieu in the Global City
Principal Investigator: Thomas A. Hutton

In April 2000, the UBC Hampton Fund awarded \$14,150 for this project which proposes to (1) generate empirical profiles of design and creative industries in sites within cities at three global city levels (the South Bank and Bankside districts of London; the South of Market and Northeast Mission districts of San Francisco; and the Yaletown, Victory Square and Gastown areas of Vancouver) to enable comparisons of industry concentration, scale, specialisation and 'image' or 'identity,' and (2) contribute to the conceptual architecture on inner city economic change and its critical intersections with urban society, culture, and *milieu*. The project entails a literature review, deployment (and testing) of the investigator's conceptual framework, and field work, entailing key informant interviews and field surveys of land use and industrial change in each site. Expected outcomes include (1) a working paper and refereed journal article (for *Urban Studies*); (2) innovative new models of inner city change, and an empirically accountable framework for examining the 'socio-cultural bases of urban tertiarization,' and (3) a powerful scholarly platform for the development of a strategic-level SSHRC grant application on service industries, society, culture and urban transformation.

CHINA

3x3: Sustainable Water Resources Management in the Beijing-Tianjin Region (SWRM)

A. Project Director, Michael Leaf; Project Coordinator, Donna Yeung

This project, which began in April 1998 and will be completed in July 2002, received funding of \$826,000 from the Canada-China Higher Education Program of the Canadian International Development Agency (CIDA) in order to conduct research and training programs involving issues of water pricing, demand, supply, geographic information systems, environmental impact assessment and governance policy.

The project involves seven partner universities, including:

- The University of British Columbia

- The University of Toronto
- McGill University
- The University of Montreal
- Peking University
- Tsinghua (Qinghua) University
- Nankai University

The primary goals of this project are to:

- 1) Fund graduate student research and technology training
- 2) Provide equipment acquisition for research laboratories
- 3) Develop workshops to facilitate dialogue between local communities, academics and government agencies, and
- 4) Make policy recommendations to relevant governing agencies

In this reporting period, major activities include:

- 1) Student field research in the Beijing-Tianjin region conducted by 8 Chinese and 4 Canadian graduate students for periods ranging from 2-6 months;
- 2) Community meetings with several government bureaux hosted and facilitated by partner Nankai University;
- 3) Ground-proofing exercises to validate statistical data and satellite imagery used in research analysis;
- 4) Our annual strategic planning & management meetings;
- 5) Maintenance of regular administrative systems; and
- 6) Development of a comprehensive web site for research dissemination;

In the upcoming year, decisions and related activities regarding publication of research findings as well as further networking with governments and community groups will be undertaken.

Community-based Urban Environmental Management in Quanzhou, Fujian, China

Project Leaders: Michael Leaf, Daniel Abramson, Tan Ying (Tsinghua University), and Tao Tao (Chinese Academy of Urban Planning and Design)

From November 1999 to July 2002, the Governance and Civil Society Unit of the Ford Foundation's Beijing Office is granting US\$134,000 to Tsinghua University School of Architecture, the Chinese Academy of Urban Planning and Design (CAUPD), and UBC Centre for Human Settlements to facilitate engagement between residents of a neighborhood in the city centre of Quanzhou, Fujian Province, China, and the municipal government of that city on issues of neighborhood infrastructure upgrading, self-built housing regulation and historic preservation. Quanzhou, due to its particular history of tight connections with Overseas Chinese communities and its dynamic private-sector economy and property structure, is a classic case of the difficulties facing conventional state-dominated urban management in China. The object of this project is to explore how more active citizen involvement in urban planning and management in the city will not only make regulatory structures more rational and easy to enforce, but will also uncover alternative sources of investment in urban services and improvements.

The CHS-Tsinghua-CAUPD team has been organizing the following activities:

- (1) Surveys of community-level business and social organizations

- (2) workshop-style meetings which acquainted both residents and planning officials with interactive techniques of discussion; made the existence of conflicting interests an explicit and legitimate topic of discussion; formed a “core group” of residents willing to keep the community informed and involved; identified what different interests there are within the community; and devised a range of policy options and corresponding trade-offs to respond to each interest;
- (3) publicity, including: close coordination of project activities with festivals, and general close contact with television and newspaper media, which are unusually free to choose their own agenda in Quanzhou;
- (4) a series of technical and design-oriented activities to further clarify various interests and their associated trade-offs, including: a *Planning for Real*-like community modeling exercise in which residents identified problems and opportunities for action by placing cards on a model of their neighborhood.

Preparations were made to continue the design-oriented activities in the form of a private housing “design clinic” in which UBC and Tsinghua students would work with volunteer households to seek common ground between residents’ self-building intentions and government regulations; a public space “envisioning” exercise in which different degrees of change and intervention as proposed by students, planning authorities and residents were illustrated in photo-edited images of the neighborhood lane; a set of design guidelines to make explicit the relationship between specific design requirements and the principles underlying them; a technical study of upgrading options that the Planning Bureau has commissioned one student member of the Tsinghua-CHS team to prepare as a parallel product that informs and is informed by the participatory process as a whole; finally, an action plan that links regulation compliance with investments in public facilities upgrading.

The final stage of the project is to involve the institutionalization of participation through the modification of the neighborhood committee structure and administrative reforms within the planning authority that would enable on-going use of the process in the project community and in other neighborhoods in Quanzhou.

SRI LANKA

Education for Democratic Planning in Sri Lanka

Project Leaders: Penny Gurstein & Michael Leaf; Project Coordinator: Mikiko Terashima

This five-year capacity building project began in June 1997 with funding of \$750,000 from the Association of Universities and Colleges of Canada (AUCC) through the University Partnerships in Cooperation and development Program of CIDA. It aims to contribute to a stable and pluralistic democracy in Sri Lanka by strengthening the community and regional planning system at local government levels. Its goals are to (1) establish a graduate-level community and regional planning program at the University of Peradeniya and undergraduate programs at the Universities of Ruhuna and Jaffna; (2) carry out short-term colloquial programs for practising Sri Lankan planners at the regional, provincial, city, district, divisional and local community levels; (3) offer graduate fellowships to Sri Lankan faculty members to study community and regional planning at UBC; and (4) carry out pilot projects or in depth case studies on community and regional planning issues in Sri Lanka.

During the current year, the second Sri Lankan faculty member from Ruhuna University began his PhD-level studies at SCARP; the third policy workshop on the theme of “Reconstruction and Redevelopment in Northern Sri Lanka” was held at Jaffna University; curriculum planning workshops were held at the

University of Peradeniya and in Colombo, the latter being hosted by the Sri Lankan Institute of Town and Country Planning and the University of Peradeniya.

VIETNAM

B. Localized Poverty Reduction in Vietnam

Project Director, Peter Boothroyd; Project Coordinator, Vince Verlaan

In April 1998, the Canadian International Development Agency (CIDA), through its University Partnerships in Cooperation and Development program, awarded CHS a \$4.8 million research grant to work with Université Laval, Vietnam's National Center for Social Sciences and Humanities (NCSSH) and five major Vietnamese universities over five years. This project aims to build self-sustaining capacity in the partner institutions to develop and teach low-cost, participatory policy assessment and project planning methods. Participatory project planning and policy assessment methods are being adapted to Vietnamese conditions and practiced to reduce poverty in fifteen of Vietnam's poorest communes. Learning from these projects will enrich the curricula and outreach programs of Vietnamese universities.

The project has five objectives: 1) formation of a well-resourced, self-sustaining Centre for Localized Poverty Reduction at each Vietnamese partner institution; 2) formation of an internationally associated, self-sustaining Vietnamese network of centres for poverty reduction; 3) reduction of poverty in fifteen representative communes through specific learn-by-doing policy assessment and planning projects related to livelihood protection, income generation, and service accessibility; 4) production of knowledge about effective participatory methods, and dissemination of this knowledge to other communes, government agencies, NGOs, and educational institutions; and 5) broadened and deepened relations between Canadians and Vietnamese institutions and people.

Highlights of Year 2 include:

Administrative Systems: Coordinators are in place at UBC, Laval and at the National Centre for Social Sciences and Humanities in Vietnam. They are responsible for managing the various administrative systems for LPRV in coordination with coordinators at each university in Vietnam.

Centres for Poverty Reduction (CPRs) Network Development: Electronic linkages between the 6 CPRs in Vietnam were further developed in the latter part of 1999. Beyond technical assistance, network development focused on training and information resource collection.

Commune Projects in Vietnam: The core of the LPRV program is a series of village and commune-level projects involving local people and university faculty and students. Detailed planning for these projects (and formal government approval for starting work in the chosen communes) got underway in 1999/00. LPRV benefited from the participation of interns in various aspects of the yearly workplan, with a main focus upon planning for commune projects. Separate funding for the interns comes from CIDA and WUSC.

Gender Analysis: Various training and research activities to strengthen the "Gender Analysis" capacity of participating students and faculty in Canada and Vietnam were undertaken in this very active area.

Training: In the area of Poverty Policy Assessment, case studies and data related to national poverty reduction policy efforts in ASEAN were initially collected, shared among and reviewed by the faculty members of the eight participating institutions in LPRV.

Each Vietnamese university partner provided its Canadian partners with a listing, summary and course outline for their existing courses and degree programs related to poverty reduction. This will aid in planning future training course and curricula development.

Terry McGee, Nora Angeles and Steffanie Scott compiled a list of references in the following areas: participatory rural appraisal; power and participatory development and research; gender and participation; gender, environment and household analysis; challenges and experiences in institutionalizing participation in development; participatory methods and tools; social capital, good governance and impact assessment; and qualitative and quantitative methods.

The LPRV program worked with the World University Service of Canada to develop part-time English and French language teaching programs for the faculty and students at each of the participating universities in Vietnam.

Dr. Leonora Angeles organized a 10 day study tour in the Philippines in January, 2000. Participants, mid-career faculty members of the five Vietnamese university partners, toured the Philippines to examine poverty reduction programs. They visited university programs, NGO projects, and government offices where multi-sectoral poverty reduction efforts are well established.

A workshop on "Government, Quasi-Governmental, Non-Government Organization and Community Responses to Poverty in Five Southeast Asian Countries", was held at the University of Dalat on January 19 and 20, 2000.

CHS RESEARCH CENTRES

Disaster Preparedness Resource Centre (DPRC)

Director: Wayne Green; Project Manager and Development: Diana Ericson

The Disaster Preparedness Resource Centre's activities are focused on natural and human-induced disasters and their enormous consequences to the community. The Centre offers a specialized collection of books, reports, journals, newsletters, slides and videotapes, as well as a listing of websites and databases of special interest. An important mandate of the Centre is the facilitation of research projects and planning initiatives for counter-disaster and mitigation activities. Research and community service projects involve SCARP students as well as disaster preparedness planners and managers in government, private industry and community groups. Through the organization of conferences, talks and seminars, as well as the publication of its newsletter, *SIGNALS*, the Centre provides a vital forum for information sharing among emergency planners and management professionals.

5th Asia Pacific Conference on Disaster Medicine

During the year, preparations continued for the Fifth Asia Pacific Conference on Disaster Medicine, which will be held in Vancouver at the Empire Landmark Hotel from September 27-30, 2000. Co-sponsored with the UBC Faculty of Medicine and the Government of Canada, the conference will provide a forum for the international community, health professionals and disaster experts, as well as government and non-government agencies, to explore disaster management techniques and to discuss emergency medical methods, models, and technologies. In May 2000, a cost-sharing agreement was signed with the Canadian International Development Agency (CIDA), in which CIDA agreed to fund the costs (up to \$50,000.00) associated with the participation of representatives from developing countries and countries in transition. As well, funding of \$7,000.00 was obtained from Emergency Preparedness Canada for the production of the 5th APCDM Summary Document and Action Plan upon completion of the conference.

Eco Risk Research Unit (ERRU)

C. Director: Tim McDaniels

The Eco-Risk Research Unit is an interdisciplinary collaboration of policy analysts, risk management specialists, and scientists at UBC focused on (1) providing insight for human choices that influence ecological processes; (2) applying technical knowledge, policy strategies and analytical methods to key environmental policy questions; (3) advancing the state of knowledge for concepts and methods concerned with the use of policy analysis and modelling for understanding ecological risk trade-offs; and (4) conducting socially valuable research that helps frame thinking and debate about ecological risk management policy issues.

To assess the state of current knowledge on the linkages among: development aid; development work (through NGOs, universities, etc.); strengthening of regional (sub-national) civil society; integrative (systems-sensitive) policy assessment; policy making; policy implementation; societal system change; sustainable (preventative and ameliorative) poverty reduction. What is known

about blockages in this chain? And about front-end (development aid/work) solutions that unblock the blockages?

2. To develop objectives, themes, and structure for an ongoing, international, action-oriented program of research (a “conquiry”) that furthers knowledge on the above linkages, blockages, and solutions.
3. To plan the format and name for an annual summer institute where research from the conquiry is presented and applied, and future research agendas are built.
4. To plan the agenda and preparatory process for the first annual summer institute in the conquiry, to be held at UBC, June 2001.
