## **Highlights In 2001/2002**

The School of Community and Regional Planning will begin commemoration of its 50th anniversary this spring through a series of special events and activities. A 12-month celebration period will begin with several events connected to the CIP conference in Vancouver in May 2002 and conclude with the graduation ceremonies in May 2003, which would link to the 50th Anniversary of the first graduation ceremony (first 3 students graduated from SCARP in 1953).

SCARP students Marlene Wells, Preet Heer, and Rebecca Koeller have initiated a fun and creative project as part of the 50th anniversary celebrations: the creation of a community quilt that will express the history, ideas and vision of the SCARP community. Students, faculty, staff and alumni will be invited to participate in creating a community quilt. Design and fabrication of the quilt will be done through participatory exercises where many individuals' ideas come together and create one large unique expression.

Three new faculty members have joined the School. They add major new expertise and international experience in urban design, planning theory and social policy that enhances the School's teaching programs and research through its Centre for Human Settlements (CHS).

Assistant Professor Elizabeth Macdonald will lead the School's teaching and research programs in Urban Design. Elizabeth has twenty years experience as a practicing architect and comes to the School from the University of Toronto. In addition, the School has launched a new urban design curriculum this term under the leadership of Elizabeth. A brand new studio facility has been constructed on the second floor of the Lasserre building, which is dedicated to the 6-credit Urban Design Studio course.

Professor Leonie Sandercock will lead the School's teaching and research programs in Planning Theory and various areas of Social Policy. Before coming to SCARP Leonie was the Associate Dean (of Graduate Studies) in the Faculty of Architecture, Building and Planning at the University of Melbourne. She has also previously taught at Macquarie University, UCLA, and the Royal Melbourne Institute of Technology.

John Friedmann has been appointed an Honorary Professor at SCARP. He will also continue as Professor Emeritus of Planning at UCLA, one of the most highly regarded planning schools in the US, where he served as the Program Head for two terms before his retirement. International recognition for John's remarkable achievements includes Honorary Doctorates from the Catholic University of Chile and the University of Dortmund, and the Distinguished Planning Educator Award of the U.S. Association of Collegiate Schools of Planning.

With the impending expansion of the Institute of Health Promotion Research in the Library Processing Centre, plans are underway for SCARP and CHS to consolidate their spatial needs into new and improved facilities at West Mall Annex. A plan for renovations of WMAX has been drafted and the first stage of remodeling and construction work will occur in August 2002. The final stage of construction will occur in August 2003. CHS will be located on the second floor of WMAX, with a reception area, seminar room, resource room, mail and copy room, and offices for faculty, research staff, and PhD students. The second floor will also house the new 'Cosmopolis Participatory Planning Lab', a multi-media laboratory designed to facilitate community participation in planning processes.

The 14th annual Emergency Preparedness Conference took place in Vancouver in October. Dr. Wayne Greene, Director of the Disaster Preparedness Resource Centre at CHS, has served as Chair of the

Conference Executive Committee of this highly successful meeting for the past 10 years. This is an opportunity for people and organizations working in the field of disaster management, planning and research to get together to share experiences and ideas.

Assistant Professor Leonora Angeles recently received two awards at UBC. She was awarded a \$5,000 UBC Killam Teaching Prize for 2001. She also received a \$5,000 UBC Women's Studies Scholar-in-Residence Award for 2001-2002.

Professor Tim McDaniels was recently selected as a Fellow of the Society for Risk Analysis. This is a distinct honor and reflects the major national and international contributions Dr. McDaniels has made to the discipline of risk analysis. The award was presented to him at the Society's Annual Meeting in Seattle in December.

Elizabeth Macdonald, Assistant Professor of Urban Design at SCARP, is the co-author of a forthcoming book: "The Boulevard Book: History, Evolution, Design of Multiway Boulevards" by Allan B. Jacobs, Elizabeth Macdonald, and Yodan Rofe.

Penny Gurstein, Associate Professor of SCARP and Faculty Research Associate, is the author of a new book: "Wired to the World, Chained to the Home: Telework in Daily Life".

Craig Davis, carer of family, friends, students, and truth, died suddenly September 18 in his home. For thirty years, Craig taught and researched economics perspectives on planning. A generation of planners was informed by his knowledge, inspired by his acuity, and warmed by his generosity. With a bachelor's degree in electrical engineering from Purdue University, Craig went on to Berkeley for post-graduate studies in economics, receiving his doctorate in 1967. He began his SCARP teaching career in 1968. He taught and wrote extensively on regional economics, impact analysis, and community economic development. Increasingly, he took a special interest in helping students to become adept at using computers in planning practice. In his few retirement years, he turned his attention to Buddhist philosophy.

## Master's Program

SCARP's Master's Program constitutes the core of its academic and professional teaching program. As one of the best-known and comprehensive Planning programs in North America we received 119 formal applications as compared to 160 in 1999-98, 123 in 1998-1997, and 121 in 1997-1998. We continued to improve our successful program completion rate, graduating 29 students in the 2001-2002 academic year.

For 2001-2002 the applicants accepting our offer had undergraduate degrees in Anthropology, Anthropology/Development Studies, Canadian Studies, Chemistry, Communications, Economics, English, Environmental Studies, Geography, Geography/Environmental Studies, History, Industrial & Systems Engineering, International Development Studies, International Development/Sociology, Natural Resources Conservation, Political Science/Environmental Sciences, Political Science/Sociology, Politics & Development and Psychology

Fifty-six applicants were admitted and 30 accepted the offer. The average age was 26 (9 were under 24 years old). 10 males and 20 females accepted our offer.

## **Centre For Human Settlements**

The Centre for Human Settlements (CHS) takes as its mission “to advance knowledge of the dynamics of, and effective methods for, democratically planning the sustainable development of settlements.” The interdisciplinary research and capacity-building programs at CHS address a multiplicity of complex community development issues. In collaboration with academic, governmental and NGO partners, CHS advances knowledge through participatory action research, field tests of proposed planning methods, institutional capacity building, and mutual learning.

CHS has an established record of research in planning for sustainable development that explores local and global paths towards achieving it. In 1991, CHS was designated an International Centre of Excellence in International Development by the Canadian International Development Agency (CIDA). Since then, the Centre has been awarded four other major CIDA grants; funding from the United Nations Development Program (UNDP) for a training program on planning for sustainability in Hanoi, Vietnam; and funding from the Social Sciences and Humanities Research Council (SSHRC) to initiate an international gender and development network.

Under the CHS umbrella, the Disaster Preparedness Resource Centre (DPRC) has been successful in obtaining funding for a variety of research and training projects and conferences. Faculty Associates have also been active in individual research projects funded by a broad spectrum of national and international funding agencies. Current projects are summarized below.

### ***BRAZIL***

*Community Based Watershed Management in Santo André*  
Project Director, Peter Boothroyd; Project Coordinator, Erika de Castro

The Community Based Watershed Management (CBWM) project is a four-year CIDA-funded project that started in October 1998. Santo André is one of thirty-nine municipalities in the Sao Paulo Metropolitan Area (SPMA), the second largest city in Latin America. Sixty percent of the municipality is located in reserve areas that were established to preserve watersheds, green areas and natural parks. The metropolitan urban expansion has been a continuous source of pressure to increase the number of people

living in the WPA, and so increasingly threatening the water quality of the metropolitan watersheds. The project has been undertaken to proactively address issues arising from human settlement in environmentally sensitive areas. The need to integrate informal and irregular settlements effectively into the urban system is the primary issue. The purposes of this project are:

1. To introduce Community-Based Watershed Management (CBWM) methods to Watershed Protection Areas in Santo André, with applicability to other communities and municipalities.
2. To improve the quality and availability of information necessary for municipal decision-making related to watershed management.
3. To expand institutional linkages between Canada and Brazil

**Highlights of the CBWM project during the past year are as follows:**

- The "Subprefeitura" (sub-municipal administration for the major part of the watershed area in Santo André) is now well established, thanks in large part to the CBWM project. It is dedicated to planning and managing the watershed areas according to the CBWM project guidelines. The Subprefeitura is increasingly working with watershed residents, enhancing their participation in planning, and fostering awareness of the complexities involved in environmental protection.
- A CBWM framework for Santo André was formulated, with drafts addressing the complex legal issues associated with illegal settlements in protected areas. The framework is being developed by holding forums with watershed communities, neighbouring municipalities, and a state official known as the "environmental prosecutor."
- A new plan for Pilot Project 1 (Parque Andreense) was presented with subdivisions that meet Environmentally Sensitive Area (ESA) and the state legal requirements. The new environmentally sensitive street design for the settlement has been implemented on one street and judged by all parties to be a success, and worthy of replicating on other streets in similar settlements. In addition, thanks to CBWM, a new playground has been built and the sports park is being developed. The planning and budgeting for expansion of existing schools has been initiated.
- Community meetings within Pilot Project 2 (Favela Pintassilgo) were held to plan settlement and local improvements. The first step was to have the community involved in environmental awareness programs.
- In the third Pilot Project area, PP3 (Paranapiacaba) plans were created for pro-poor ecotourism development in the historical village. The recent addition of this third pilot project has increased the comprehensive approach to sustainable development of environmentally sensitive areas.
- The Oral History manuscript was completed and the translation into English will begin in September 2002. It is scheduled to be printed in 2003.

The CBWM project is expected to:

- Contribute to capacity development and institutional strengthening of the Santo André Municipality and its partner organisations by helping to develop, implement and evaluate concepts and policies related to social and environmental issues.
  - Strengthen the community as an effective partner of the municipality in order to facilitate meaningful participation in the planning and management of the watershed protection area.

- Identify means to minimise damage to the environment by settlements in sensitive watershed areas, especially in informal settlements; and
- Cultivate stewardship consciousness for the watershed area residents.

**BRITISH COLUMBIA**

*Asset-based Community Development for Well-Being and Health Promotion in a Pluralistic Society*  
Principal Investigator: Penny Gurstein

This Humanities and Social Sciences Small Research Grant of \$2,000 was awarded in April 2002 to investigate social capital and the role it plays in creating networks of mutual support, caring, and sense of belonging that contribute to an individual's well-being and health; in particular, to explore the suitability of using asset-based community development methods to promote well-being and health in Greater Vancouver Chinese Communities. Asset-based community development focuses on a community's assets rather than its deficiencies. The first stage is asset-mapping which involves identifying and mapping out a wide range of assets available within the community, for example, community groups, organizations, networks and facilities. It is argued that the "fit" between available assets and the needs and behaviours of community residents is key to well-being and health outcomes. The applicability of asset-mapping techniques for promoting health within an ethnically-defined community will be assessed through a literature review, focus groups and interviews with knowledgeable professionals and community leaders, and analysis of demographic and health profiles of the Chinatown and Richmond Chinese communities. The outcomes of this project will be used as the foundation for a major proposal on this topic.

*New Service Clusters in the Metropolitan Core: Intersections of Tertiarization, Urban Culture and Milieu in the Global City*

Principal Investigator: Thomas A. Hutton

In April 2000, the UBC Hampton Fund awarded \$14,150 for this project which proposes to (1) generate empirical profiles of design and creative industries in sites within cities at three global city levels (the South Bank and Bankside districts of London; the South of Market and Northeast Mission districts of San Francisco; and the Yaletown, Victory Square and Gastown areas of Vancouver) to enable comparisons of industry concentration, scale, specialisation and 'image' or 'identity,' and (2) contribute to the conceptual architecture on inner city economic change and its critical intersections with urban society, culture, and *milieu*. The project entails a literature review, deployment (and testing) of the investigator's conceptual framework, and field work, entailing key informant interviews and field surveys of land use and industrial change in each site. Expected outcomes include (1) a working paper and refereed journal article (for *Urban Studies*); (2) innovative new models of inner city change, and an empirically accountable framework for examining the 'socio-cultural bases of urban tertiarization,'" and (3) a powerful scholarly platform for the development of a strategic-level SSHRC grant application on service industries, society, culture and urban transformation.

*Exploratory Workshop—Service Industries and New Models of Urban Change within the Asia-Pacific*  
Principal Investigator: Thomas A. Hutton

Following forty years of (often policy-induced) *industrialization*, it is apparent that service industries (especially advanced services, such as finance, information- and technology-based services) are playing more central roles in urban development within the broadly-defined Asia-Pacific. The pace and far-reaching effects of this recent service growth (or tertiarization) has generated a significant demand for theoretical and normative research that is at the social science frontier for the new century.

---

In April 2001, the Peter Wall Institute for Advanced Studies awarded \$15,000 for an exploratory workshop which was held in March 2002 and brought together UBC Asian urban scholars, including graduate students, with leading international service industry specialists (1) to develop a stimulating, interdisciplinary discourse on the three principal consequences of urban service industry growth: (a. new development trajectories, b. changes in urban structure, space and form, c. implications for urban social structure); (2) to establish priorities for new scholarly investigations derived from these analyses and discussions, and (3) to develop a collaborative approach prior to the preparation of a strategic-level grant application. Workshop sessions addressed fundamental research issues pertaining to models of urban services projection networks, new divisions of urban labour, and implications of services growth for spatial models.

This workshop significantly contributed to new knowledge on the role of service industries in processes of urban change within the Asia-Pacific; generated manuscripts to be included in a new book to be co-edited by Peter Daniels (University of Birmingham), Kong Chong Ho (National University of Singapore) and Dr. Tom Hutton; and substantially informed a paper that Dr. Hutton is preparing for submission to *Progress in Planning* entitled "Service Industries, Globalization, and Urban Restructuring within the Asia-Pacific: New Development Trajectories and Planning Responses."

*New Service Economy of the Inner City: An International Comparative Study*  
Principal Investigator: Thomas A. Hutton

On January 15, 2002, SSHRC awarded a development grant of \$32,515 under its Initiative on the New Economy Program for this research project which addresses fundamental issues concerning the critical spatial dimensions of the new economy and, more specifically, the role played by the inner city in hosting design, technology-based, and design/technology 'hybrid' firms. These firm clusters, located in response to the unique urban, economic and socio-cultural agglomeration attributes of inner city terrains, typify new urban development trajectories in the 21<sup>st</sup> century and constitute essential features of the 'new economy' in Canada and other advanced societies.

This project extends current work on cluster-driven urban development in Canada to offer a comparative study of selected inner city sites in five cities at different levels of the global urban hierarchy: London, Singapore, San Francisco, Seattle and Vancouver. Field work will disclose broad commonalities in 'new economy' trajectories and development patterns across the sample, as well as important contrasts associated with urban scale, local development conditions, and public policy experiences. Key findings will address changing division of labour, the operation of area-based production networks, implications for urban land use, and the breadth of planning and policy options pertaining to the emergence of new inner city production districts.

## **CHINA**

*3.3: Sustainable Water Resources Management in the Beijing-Tianjin Region (SWRM)*  
Project Director: Michael Leaf; Project Coordinator: Donna Yeung

The Sustainable Water Resources Management in the Beijing-Tianjin Region (SWRM) project is a four-year project funded by the Canadian International Development Agency (CIDA). Under CIDA's Canada-China Higher Education Program, the project receives funding for research and training involving issues of water pricing, demand, supply, geographic information systems, environmental impact assessment and governance policy.

---

The project involves seven partner universities, including:

- The University of British Columbia
- The University of Toronto
- McGill University
- The University of Montreal
- Peking University
- Tsinghua (Qinghua) University
- Nankai University

The primary goals of this project are to:

- 1) Fund graduate student research and technology training,
- 2) Provide equipment acquisition for research laboratories,
- 3) Develop workshops to facilitate dialogue between local communities, academics and government agencies, and
- 4) Make policy recommendations to relevant governing agencies.

In this reporting period, major activities include:

- 1) Student field research in the Beijing-Tianjin region conducted by 6 Chinese and 6 Canadian graduate students for periods ranging from 2-6 months
- 2) Environmental Impact Assessment workshops in Tianjin, China
- 3) Strategic Environmental Impact Assessment Training Modules launched in Tianjin
- 4) Our annual strategic planning & management meetings
- 5) Maintenance of regular administrative systems
- 6) CD-Rom Publication Chapters prepared for production
- 7) Completed Masters thesis papers by 4 graduate students and 2 PhD students

*Community-based Urban Environmental Management in Quanzhou, Fujian, China*

Project Leaders: Michael Leaf, Daniel Abramson, Tan Ying (Tsinghua University), and Tao Tao (Chinese Academy of Urban Planning and Design)

Since November 1999, the Governance and Civil Society Unit of the Ford Foundation's Beijing Office has provided funding of US\$134,000 to Tsinghua University School of Architecture, the Chinese Academy of Urban Planning and Design (CAUPD) and the UBC Centre for Human Settlements to facilitate engagement between residents of a neighborhood in the city centre of Quanzhou, Fujian Province, China, and the municipal government of that city on issues of neighborhood infrastructure upgrading, self-built housing regulation and historic preservation. Quanzhou, due to its particular history of tight connections with Overseas Chinese communities and its dynamic private-sector economy and property structure, is a classic case of the difficulties facing conventional state-dominated urban management in China. The object of this project is to explore how more active citizen involvement in urban planning and management in the city will not only make regulatory structures more rational and easy to enforce, but will also uncover alternative sources of investment in urban services and improvements.

*State Society Interactions in the Management of Chinese Urbanization: Study of Quanzhou*

Project Leader: Michael Leaf

---

In May 2000, the UBC Hampton Fund awarded \$30,000 for this two-year research project which examines the role of social organizations with respect to urban management and services provision in Quanzhou, China, in collaboration with Chinese colleagues from Tsinghua and Beijing Universities. By looking at the interrelationships between local institutions and urban management, the research is contributing to the understanding of local governance practices in China, a critical issue during this period of great social and economic change.

During the second year of the project, three SCARP Master's students received funding to conduct their field research in Quanzhou for their thesis or project: (1) Zhu (Joe) Qian: *Toward a Collaborative Approach to Urban Conservation Planning in China: An Analysis with Reference to Quanzhou, Fujian Province* (thesis); (2) Tianyu (Jack) Chen: *A Guidebook for the Implementation of Heritage Revitalization, with Special Reference to the Case of Quanzhou, Fujian, China* (project); and (3) Samantha Anderson: *Cities on the Edge: Periurbanisation in South-east China* (thesis)

In addition, Professor Michael Leaf was invited to present a paper, "An Urban World: Implications for Peri-urban China," at a conference on Cross-straits Cooperation for Study of Urban Change and Development in Quanzhou, China on July 8, 2002.

### ***SRI LANKA***

#### *Education for Democratic Planning in Sri Lanka*

Project Leaders: Penny Gurstein & Michael Leaf; Project Coordinator: Mikiko Terashima

This five-year capacity building project began in June 1997 with funding of \$750,000 from the Association of Universities and Colleges of Canada (AUCC) through the University Partnerships in Cooperation and development Program of CIDA. It aims to contribute to a stable and pluralistic democracy in Sri Lanka by strengthening the community and regional planning system at local government levels. Its goals are to (1) establish a graduate-level community and regional planning program at the University of Peradeniya and undergraduate programs at the Universities of Ruhuna and Jaffna; (2) carry out short-term colloquial programs for practising Sri Lankan planners at the regional, provincial, city, district, divisional and local community levels; (3) offer graduate fellowships to Sri Lankan faculty members to study community and regional planning at UBC; and (4) carry out pilot projects or in depth case studies on community and regional planning issues in Sri Lanka.

During 2001/02, the faculty members from the Universities of Ruhuna and Jaffna continued their studies at SCARP. In March 2002, Mr. Rupananda Widanage from the University of Ruhuna successfully defended his doctoral thesis prospectus and subsequently returned to Sri Lanka to conduct his field research. Workshops and meetings were held in July and November 2001: on "Informal Housing" at the University of Peradeniya and on "Curriculum Development" at the University of Jaffna. Proceedings for all of the workshops held during the project were published and distributed, and computers and office equipment were purchased for the planning programs at the University of Jaffna and the University of Ruhuna.

### ***VIETNAM***

#### *Localized Poverty Reduction in Vietnam (LPRV)*

Project Director, Peter Boothroyd; Project Coordinator, Vince Verlaan

The Localized Poverty Reduction in Vietnam (LPRV) program has entered Year 4 of its five-year lifespan (1998-2003). The overall LPRV approach is to develop at each institution a Centre for Poverty Reduction (CPR) through which participatory methods can be explored with government locally. LPRV activities centre on participatory community-level poverty reduction projects, development of new curricula and learning methods for university students and government officials, and inputs to government policies and programs concerned with hunger eradication and poverty reduction. The lessons learned through all these activities are shared nationally through activities coordinated by the National Centre for Social Sciences and Humanities (NCSSH).

---

Over the life of the LPRV program, all partners have jointly developed and implemented annual workplans that move the program as a whole towards its overall objectives. Activities in Year 4 of LPRV focussed on:

- Planning, implementing, and learning from the first 10 commune-level projects; drafting and preparing 5 more for launch in year 5; developing richer project activity documentation tools and report formats, resulting in greater exchanges of lessons learned and in greater collaboration on project methods.
- Developing more detailed plans for sustainability of CPRs, and developing ongoing project activities such as biogas at Hue, consulting at HCMC CPR, etc.
- Adding to or building on specific skill or methodology areas as needed by various project partners. This involved drawing on Canadian, Vietnamese, academic or NGO skills and resources in response to challenges being encountered by university partners in their LPRV activities.
- Developing the outlines for two summative books on overall lessons learned from LPRV, to be developed by UBC, and developing ideas for a summative book by NCSSH and one by Laval.
- Further developing the human resources and activities of the Coordinating Centre for Poverty Reduction (CCPR) at the National Centre for Social Sciences and Humanities (NCSSH) as a key sustainability strategy. A key activity of the CCPR was continuing to build the Network of CPRs centred on the CCPR, and connecting that network to other Vietnamese ministries active in poverty reduction, as well as to other donors.
- Planning and assessment with each of the CPRs by CCPR resource persons.
- Articulating and communicating LPRV strategies and results and developing a network newsletter by the CCPR with Canadians and universities.
- Developing and circulating seven new curriculum units that are linked by their theme of participatory poverty reduction.
- Forming an Editing Board involving members of all Vietnamese partners, to expedite and improve quality of curriculum units and to manage schedule for their completion.
- Creating an initial training package for government officials (“Doing Poverty Reduction Together”) designed and delivered by the CCPR and Thai Nguyen University.
- Developing the potential for CPRs and NCSSH to contribute to policy assessment through the development of a strong and active policy assessment group.

## **CHS RESEARCH CENTRES**

### ***DISASTER PREPAREDNESS RESOURCE CENTRE***

Director: Wayne Green; Project Manager and Development: Diana Ericson

---

The goal of the Disaster Preparedness Resource Centre (DPRC) at CHS is two-fold: 1) the provision of resources in the area of disaster planning and management; and 2) the promotion of sustainable communities through the incorporation of disaster planning into regional and community planning. The DPRC supports research in disaster preparedness, mitigation, response and recovery through interdisciplinary collaboration, under the direction of Dr. Wayne Greene.

Research and community service projects conducted by the DPRC involve SCARP students as well as disaster preparedness planners and managers at all levels of government, private industry, and community groups. The Centre maintains links to other centers and institutions in North America and elsewhere, and hosts conferences and workshops that bring together professionals and academics to share expertise on disaster issues.

The scope of the DPRC's work is international and multi-hazard, but the emphasis is on Canadian issues and institutions, planning, and preparedness, and earthquake and earthquake-related issues and their mitigation. Resources at the Centre include print, audio-visual and computerized data. The DPRC resources can be accessed from the UBC Library Web site: <http://www.library.ubc.ca/home/more.html>.

During the past year, DPRC staff prepared proposals which were submitted to possible funders, attended the 26<sup>th</sup> Annual Workshop on Hazards Research and Applications at the University of Colorado, and presented a poster at the National Natural Hazards Assessment Project Workshop in Toronto, May 9-16, 2001.

***Eco Risk Research Unit (ERRU)***  
**Director: Tim McDaniels**

The Eco-Risk Research Unit is an interdisciplinary collaboration of policy analysts, risk management specialists, and scientists at UBC focused on (1) providing insight for human choices that influence ecological processes; (2) applying technical knowledge, policy strategies and analytical methods to key environmental policy questions; (3) advancing the state of knowledge for concepts and methods concerned with the use of policy analysis and modeling for understanding ecological risk trade-offs; and (4) conducting socially valuable research that helps frame thinking and debate about ecological risk management policy issues.

Current projects include:

1. Developing a Prescriptive Decision Process for Environmental Risk Management: Concepts and Application, a UBC Hampton Fund Research Grant of \$19,000 (May 1998 to April 2000 and ongoing). Researcher: Tim McDaniels (with James Zidek, Statistics)
2. Adaptive Learning as a Strategy for Decision Processes regarding Regional and Global Environmental Change Policies AND Values, Valuation and Decision Processes for Resource Management Issues, NSF:Research Programs in collaboration with Carnegie Mellon University (July 2000 to June 2003). Grant Agreement of \$213,664.13. Researcher: Tim McDaniels.
